The sessions were led by a certified counselor and survivors of human trafficking and asked participants to consider a dream they have through personal reflection and creating a vision board. Nine awards were made for a total of \$16,521. These included materials for a survivor to launch a street outreach non-profit, and supporting the growth of a survivor-run business
